

IOSCO TOWNSHIP BOARD
REGULAR MEETING
MINUTES
December 21st , 2017

Supervisor Miller called the meeting to order with the Pledge of Allegiance at 8:00PM. Trustee Parker, Treasurer Bonnville, and Clerk Delmerico present. Trustee VanHouten absent. Also present was Zoning Administrator/Assessor Allen.

Parker made a Motion to approve the Agenda; seconded by Bonnville. All Ayes, Motion Carried (AA, MC)

There was no response to the 1st Call to the Public.

Parker made a Motion to adopt the proposed Board Minutes of November 16th, 2017; with corrections. Bonnville seconded the Motion.

The Treasurer presented the monthly report: As of this date, the Township has a General Funding Checking balance of \$489,056.54, with \$250,228.71 in the Saving Account, and \$202,116.62 in the Certificate of Deposit.

Delmerico made a Motion to pay \$30,347.30 in Township bills; seconded by Parker. Roll Call vote, AA, MC.

Bonnville reported that the Fowlerville Fire Authority had made 1 fire run, and 8 medical runs in the month of November.

Parker reported that at the December Planning Commission meeting, the members had gone over the results of the Workshop meeting earlier in the the month with the Planner.

Allen reported that Crider's property had been cleaned up, and the garage sale issue on Cedar River Estate Road has been resolved. Additionally, the dome home on Coon Lake Road is waiting for action by the Fowlerville Fire Authority before it can be demolished.

Delmerico made a Motion to approve the rate of 150% above the 2018 Federal Poverty Income Guidelines, for the purposes of Board of Review activity. Parker seconded the Motion. AA, MC.

After discussion, Delmerico made a Motion, seconded by Bonnville for the Board to review, at the February meeting, an Opt-Out Medical Marijuana Facilities Resolution. AA, MC.

The Clerk notified the Board that the Annual Fowlerville Recreation Board Meeting would be held on January 24th, 2018 at 7:00PM, in the media room of Fowlerville High School.

After a discussion, Bonnville made a Motion; seconded by Miller to authorize the Clerk to purchase a replacement printer for Qualified Voter File Computer, for a cost not too

exceed \$250.00. Roll Call vote, AA, MC.

Bonnville made a Motion to authorize the Clerk to purchase up to \$500.00 in stamps from the Webberville Post Office; seconded by Parker. Roll Call vote, AA, MC.

There was no response to the 2nd Call to The Public.

Delmerico made a Motion to Adjourn at 8:47PM; seconded by Parker. AA, MC.
