## TOWNSHIP OF IOSCO

#### ORDINANCE NO 14

### SOLID WASTE DISPOSAL ORDINANCE

An ordinance enacted pursuant to the authority of Act 246 of public acts of 1945, as amended, and Act 191 of Public Acts of 1939, as amended, to control, prevent, reduce, and/or eliminate contamination and pollution of the soils, waters and air in Iosco Township; to promote, protect, and preserve the health, safety, and general welfare of persons and property within the Township; to provide for the enforcement hereof and to provide penalties for violations hereof.

The Township of Iosco, County of Livingston, State of Michigan, ordains:

#### Section 1.0 - Title

This ordinance shall be known and cited as the Iosco Township Solid Waste Disposal Ordinance. In any action for enforcement of the provisions hereof it shall be sufficient to define the ordinance by such title and reference to the appropriate section number hereof.

### Section 2.0 - Purpose

It shall be the purpose of this ordinance to control, prevent, reduce, and/or eliminate contamination and pollution of the soils, waters, and air in Iosco Township; to promote, protect, and preserve the health, safety, and general welfare of persons and property within the Township; to provide for the enforcement hereof and to provide penalties for violations hereof.

#### Section 3.0 - Definitions

- A. "Disposal area" means a solid waste trasfer facility, incinerator for other than personal purposes, sanitary landfill, processing plant, or other solid waste handling or disposal facility utilized in the disposal of solid waste.
- B. "Solid waste" means, but is not limited to garbage, rubbish, ashes, incinerator ash, incinerator residue, street cleaning, municipal and industrial sludges, solid commercial and solid industrial waste, animal waste other then for a bona fide farming operation, ferrous or non-ferrous scrap, slag or products and sludges.
- C. "Person" means and individual, sole proprietorship, partnership, association, corporation, public or private, organized or existing under the laws of this state or any other state, including a federal corporation; and this state or any agency or a department of this state; a municipality in this state; or a county in this state.

### Section 4.0 - Disposal Area Operations

No person shall, within the Township of Iosco, operate a disposal area as herein defined for the handling of solid waste in any district. This ordinance is not intended to, and shall not, apply to bona fide farming operations.

# Section 5 0 Violation; Misdemeanor; Penalty

Any person who shall violate the terms of this ordinance shall, upon conviction in a court of competent jurisdiction, be guilty of a misemeanor and be subject to a fine of not more than \$500, or by imprisonment in the county jail not to exceed 90 days, or by both such fine and imprisonment. Each day that a violation exists shall be considered and treated as a separate offense.
